A Review of the ASHE paper on healthcare water management systems.

PRESENTATION: Details of a Risk Management Program for Healthcare Water Systems

Hospitals are increasingly in need of water risk management planning to reduce and eliminate the possibility of waterborne illness. ASHRAE recently published the new standard ASHRAE 188-2018 to establish minimum requirements for building water systems. To assist hospitals in complying with the new standard, ASHE has published a monograph that provides detailed guidance on the development and implementation of a water management program. This session offers a review of the newly published ASHE water management monograph.
